Minutes of a Parish Council Meeting held in Tissington Village Hall on Monday 12 September 2022 at 7 pm

Present:

1. Welcome and apologies for absence

The meeting observed a one-minute silence in memory of Queen Elizabeth II.

Cllr FitzHerbert welcomed everyone to the meeting. Apologies were received from Cllr Naylor and Cllr Carr.

2. Declarations of Interest

Cllr FitzHerbert declared an interest as a District Councillor.

3. Approval of Minutes of meeting held on the 25 July 2022

The Council resolved to accept the minutes of the last meeting as a true record of that meeting.

4. Matters Arising from the last meeting

The Council were still awaiting a decision regarding the application for a new build property above Sharplow Cottages.

Regarding litter on the Tissington Trail, Cllr FitzHerbert had obtained litter pickers and 2 residents had agreed to collect the litter.

The Garden Fete had raised around £2,000.

The Jubilee Celebration event had been a successful evening, total expenses had been £1,650. £1,200 had been received in grants from the District Council, Parish Council and Village Hall Committee, the Estate had kindly agreed to bear the remaining cost.

5. Invited comments from members of the public

There were no members of the public present at this meeting.

6. Planning Applications for consideration at this meeting: NP/DDD/0722/0984 - 4 Station Cottage, The Green, Tissington - Two storey side extension and detached garage

The Council resolved that they had no objection to this application and trusted that there would be no further development on this site at any time in the future. **Action: Clerk**

7. General Business:

a) Permanent Commemoration of the Queen's Platinum Jubilee

A number of suggestions for a permanent commemoration had been received. Including tree sculpture, tree planting, a fourth bell for the church, a plaque in church and planting of red, white and blue flowers. After careful consideration the Council agreed that they would explore the idea of a

wood sculpture of the Queen. Cllr FitzHerbert to contact wood carver. The Council also agreed that they would plant an oak tree, the location to be decided in due course. **Action: Cllr FitzHerbert**

8. Financial Report & Administration:

a) Update on Finances

The balance in the current account was £7,235.15.

9. Clerk's Report & Correspondence

A County Council meeting with Parish Councils had been cancelled due to the funeral of the Queen, this would be re-arranged in due course. A resident had expressed an interest in joining the Council. The Clerk stated that there were currently no vacancies and 5 Councillors was the maximum number allowed, but Parish Council elections would be held in May 2023.

10. Village Highways/Tissington Estate Business:

a) Update on items previously reported

- Potholes on Flatts Lane – these were still awaiting repair
- Repainting of white lines in the village – this had been requested but was still outstanding
- Gate post near Game Keepers Cottage – this was still outstanding; Clerk had requested that this work be done as soon as possible to prevent animals escaping.

b) Issues raised at this meeting

- The tarmac path on the ginnel along Herbert's Hollow to Greystones/Foot Cottage had been repaired but the repairs were not very satisfactory. Cllr FitzHerbert agreed to look into this matter. **Action: Cllr FitzHerbert**
