1. Welcome and apologies for absence

Cllr FitzHerbert welcomed everyone to the meeting. Apologies were received from Cllr Simon Spencer (DCC).

2. Declarations of Interest

3. Approval of Minutes of meeting held on the 22 November 2022

The Council resolved to accept the minutes of the last meeting held on the 22 November 2021 as a true record of that meeting proposed by Cllr FitzHerbert seconded by Cllr Naylor.

4. Matters Arising from the last meeting

Work on the silt trap in the pond is in hand. The yew around the Hall Well still needed to be cut back. The new Peak Park Ranger was interested in installing a step and rail at Granny's Bridge on the Tissington Trail. The quote for a new bench to go near the pond had been accepted by the Finney Family.

5. General Business:

a) Village Events for 2022 - Well Dressings/Garden Party

The Well Dressings would start on Thursday 26 May. A village litter pick would be organised in early March. No date had yet been set for the Garden Party, Cllr FitzHerbert to pass on the date for this event to the Clerk in due course. **Action: Cllr FitzHerbert**

8. Village Highways/Tissington Estate Business:

a) Update on items previously reported

- I) Potholes on Flatts Lane these had still not been repaired. Clerk to follow up.
- II) Broken Fence & Cattle Grid on Bent Lane still required work, Clerk to resend photos.
- III) Pedestrian Gate at the Cattle Grid near the Candle Factory this was still being left open, Clerk to ask the County Council to fit a new spring.
- IV) Sweeping of Flatts Lane This matter was being passed between the County and District Councils, Clerk to follow up.
- V) White Lines at Narlow Lane junction and the Old Dog these had still not been painted, Clerk to follow up.
- VI) Mud and subsidence in The Foot Clerk to follow up.

b) Issues raised at this meeting

The main Tissington gates have now been erected, following damage caused by several accidents. Planning officer has visited the site. Tissington Estate has put in planning application to improve the junction, the Police and County Council are in favour.

Work has begun on The Lodge at the end of the Avenue.

There had been a recent accident on the A515 at Newton Grange which had destroyed a large stretch of stone wall.

An accident in the Avenue had taken out several wooden posts.
