The Parish Council carefully considered the request from the Church committee for a contribution towards the new church path, which meant that the path renewal would extend beyond the church gate to the road near Hall Well. A sum of £1000 was agreed and paid. The parish council continues to cover the cost of the brass band at the Church Fete, although this is no longer supported by DDDC.

The parish council continues to support the project to keep Tissington tidy with litter picking campaigns, which saw in excess of 50 bags of rubbish being collected. Well done and thank you to all who participated.

This year also saw the introduction of a new online system of Parish Council Financial Transparency, the chairman would encourage everyone with internet availability to view the website and face book page.
